APPLICATION TIPS

Complete the application in its entirety.

Applicants must complete their entire work history and **education on the application.** Resumes are NOT accepted in lieu of an application.

Read the Minimum Education and Experience Requirements section thoroughly.

If your application does not clearly document that you meet the minimum requirements listed, your application will not be considered for that job.

Fine-tune your application to each specific job.

Clearly list and highlight the knowledge, skills, and abilities or competencies that make you a strong fit for the position.

Proofread.

Double check your application before submitting, or have someone else proofread it for errors.

Sell yourself.

Be assertive. The best way to sell yourself is to focus on the strengths you possess and the ways you could be an asset.

Do not falsify any information.

The State of North Carolina verifies application information and if any information is determined to be false, your job offer can be rescinded, or if you are already employed, you can be dismissed.

EMPLOYMENT SECURITY

The NC Division of Employment Security manages the unemployment insurance (UI) system, supporting workers in transition and businesses in processing UI taxes.



LABOR & ECONOMIC ANALYSIS

The Labor & Economic Analysis Division (LEAD) collects data, conducts research and analysis, and publishes reports about the state's economy and labor market.



RURAL ECONOMIC DEVELOPMENT

The Rural Economic Development Division (REDD) leads several grant programs and provides planning services, analysis and identification of resources needed to strengthen rural economic and community development projects.



SCIENCE, TECHNOLOGY & INNOVATION

The Science, Technology & Innovation Division works with organizations across the state to identify and communicate emerging opportunities in science and technology.
